**CONSIDERED.** HAVE SOMEONE (OTHER THAN YOURSELF) FILM YOU or use standard “selfie” lighting equipment that has a camera holder. NEVER be behind the camera, we want to see you in every shot. **Please send raw video only of you and your dish, active lifestyle activity, and answer to the question “What does The Bikini Chef” mean to you?.** Please do NOT add music, transitions, titles, or voiceovers to your video. You are the voiceover. Basic edits to allow for time are allowed but no filters, music, transitions, title cards will be accepted. Feel free to tell us about your dish, your active lifestyle activity, and answer the question. Keep in mind that the total video needs to be no more than 1-3 minutes in length.

**CONTENT:** We want to get to know you as a person, chef, cooking “expert”, your favorite active lifestyle activity, and please answer the question: **What does The Bikini Chef mean to you?.** What distinguishes you from other chefs? There is no right or wrong thing to say or do on a tape. PLEASE TELL US AND SHOW US. Have fun and be YOU!

## SHOW US:

- **INSIDE THE KITCHEN: COOKING & PLATING.** We want to see you in a kitchen, cooking a **PFF** (must have a lean protein, high fiber food, and healthy fat) compliant dish. Please wear a tasteful **bikini and wear an apron. Feel free to bring your own personality and flair to the style of the apron.** We will not see the entire bikini. Please prepare a dish that represents your culture, cuisine, lifestyle, experience, and meets The Bikini Chef Stamp of Approval guidelines of the PFFs - lean **PROTEIN**, high **FIBER FOOD**, and healthy **FAT** and be combined total of all 3 elements of no more than 6-12 ounces total for all three elements. Dish can be an entree, appetizer, soup, salad, side dish, or dessert - as long as it has those PFF elements. No need to film your entire cooking process – just record the highlights. Remember, since we can't taste your creation, impress us visually. The more unique and artistic, the better. Wow us and have fun!
- **OUTSIDE THE KITCHEN:** Don't just tell us...**SHOW** us your active lifestyle activity. We want to see you in action.
