



## ***"America's Next Bikini Chef" Contest***

### **OFFICIAL RULES**

The *"America's Next Bikini Chef" Contest* (the "Online Contest") is intended for legal residents of the United States of America ("USA") and shall only be construed and evaluated according to applicable USA law and applicable state law. Do not enter this Contest if you are not a USA resident or are otherwise ineligible to enter in accordance with these Official Rules at the time of entry. **THIS CONTEST IS IN NO WAY SPONSORED, ENDORSED OR ADMINISTERED BY, OR ASSOCIATED WITH ANY SOCIAL MEDIA PLATFORM, INCLUDING WITHOUT LIMITATION, YOUTUBE, VIMEO, OR INSTAGRAM FROM META ("SOCIAL MEDIA PLATFORM(S)").**

**SPONSOR/ADMINISTRATOR:** The "Online Contest" is sponsored by The Bikini Chef, LLC, 16192 Coastal Hwy, Lewes, DE 19958 (the "Sponsor"), and administered by the American Sweepstakes & Promotion Co., Inc., 300 State St. Suite 402, Rochester, NY 14614 (the "Administrator").

**ELIGIBILITY:** The "Online Contest" is open and offered to legal residents of the USA who are between twenty-five (25) and fifty-five (55) years of age as July 1, 2026 (the "Entrants"). The Sponsor, the Administrator, their respective parent companies, employees, officers, directors, subsidiaries, affiliates, distributors, sales representatives and advertising and promotional agencies, and the officers, directors, agents, and employees of each of the foregoing (collectively, the "Released Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are NOT eligible to participate in this Contest. Non-eligibility or non-compliance with any of these Official Rules will result in disqualification. **Void where prohibited or restricted by law.** (For the avoidance of doubt, any references in these Rules to Entrants shall also include the Entrants who are deemed the Winners (as defined below)).

**AGREEMENT TO OFFICIAL RULES:** By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the "Online Contest". Winning a Prize (defined below) is contingent upon fulfilling all requirements set forth herein.

**TIMING:** The Submission Period for Round 1 (one) of the "Online Contest" will begin at 12:00:01 am EDT on July 1, 2026, and end at 11:59:59 pm EDT on September 30, 2026 ("Submission Period Round 1"). The Judging Period for Round 1 (one) of the "Online Contest" will begin at 12:00:01 am EDT on July 1, 2026, and end at or about 11:59:59 am EDT on October 10, 2026 ("Judging Period Round 1"). The Sponsor's database clock is the official time-keeping device for the "Online Contest".

The "Online Contest" will be held via social media platforms including Instagram, Facebook, TikTok, and YouTube. Other social media platforms such as LinkedIn and Threads may also be



used. The Online Contest is simply online across social media platforms including YouTube and thebikinichef.com and americasnextbikinichef.com. No in-person auditions or competitions will be held at this time.

**HOW TO ENTER:** During the Submission Period, Entrants will be able to enter for the “Online Contest” by completing **ALL** of the following steps of entry:

1. Download the “Online Contest” Application Form at <https://americasnextbikinichef.com/> (the “Website”) and submit via the email address provided on line 3.
2. Or, complete the fillable application online at the Website
3. Send an email to [casting@thebikinichef.com](mailto:casting@thebikinichef.com) that contains ALL of the following:
  1. The fully completed Contest Application. Be sure to include your current, valid Instagram account name
  2. 3 images of your finely plated dish
  3. 3 images showcasing your active lifestyle activity
  4. A copy of the front of your driver’s license
4. Upload to YOUTUBE OR VIMEO a 1–3-minute video file showing only you and your dish, your active lifestyle activity, and answer the question, “What does The Bikini Chef mean to you?”. Your email should provide the URL address to your uploaded video. By participating, Entrants agree to Sponsor posting and sharing of your uploaded videos to The Bikini Chef® YouTube channel and website, thebikinichef.com.
5. Entrants agree to post and share their video entry to their Instagram account and tag @thebikinichef and @americasnextbikinichef. Please send a DM (direct message) on Instagram to @thebikinichef when entry submitted.
6. Sponsor reserves the right to request the Entrant video entry to be shared with Sponsor in a downloadable file sent to [casting@thebikinichef.com](mailto:casting@thebikinichef.com).

By completing all of the above steps of entry, an Entrant will receive one (1) Contest entry.  
LIMIT ONE (1) ENTRY PER ENTRANT.

All entries need to be submitted using the English language only. The Entrant is responsible for all costs associated with entry. In the event that more than one of exactly the same answers to the survey questions is submitted, only the first submission received shall be accepted. All information submitted by Entrants will be treated according to Sponsor’s Terms and Conditions, available at <https://americasnextbikinichef.com/terms/>. By participating in the “Online Contest” and providing any personal contact information, Entrants hereby agree to Sponsor’s collection and usage of their personal information and acknowledge that they have read and accepted Sponsor’s Terms and Conditions. Entrants agree to participate in any sponsor cooking or fitness challenges during the Online Contest.

**ENTRY REQUIREMENTS/RESTRICTIONS:** In order to be eligible, entries must actually be received by Sponsor during the Submission Period. Entries received by Sponsor before the start



of the Submission Period or after the end of the Submission Period will be discarded and deemed VOID. Those who do not follow all of the instructions or do not abide by these Official Rules or other instructions of Sponsor will be disqualified.

Entrants represent and warrant that their submitted entry is the original work of the Entrant, has not been previously published, has not won previous awards, and does not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity and must have been created in a legal and safe manner. If the entry contains any material or elements that are not owned by the Entrant or provided by the Sponsor, and/or are subject to the rights of third parties, the Entrant is responsible for obtaining, prior to submission of the entry, any and all releases and consents necessary to permit the use and exhibition of the entry by Sponsor in the manner set forth in these Official Rules, including, without limitation, name and likeness releases for any person who appears in or is identifiable in the entry (collectively, the "Clearances").

Each Entrant agrees that if selected to participate in any future invite only in-person auditions/competition they agree to a filmed/videotaped audition to be aired on streaming platforms with distribution nationally and internationally including internet/web distribution. Entrant will be asked to wear a swimsuit and an apron.

**GENERAL CONDITIONS:** If for any reason the operation or administration of this Contest is impaired or incapable of running as planned for any reason, including but not limited to: (a) infection by computer virus, bugs, (b) tampering, unauthorized intervention, (c) fraud, (d) technical failures, or (e) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, the Sponsor reserves the right at its sole discretion, to (i) disqualify any individual who tampers with the entry process, and/or (ii) cancel, terminate, modify or suspend the "Online Contest" in whole or in part, at any time, without notice and award the Prizes (defined below) using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be (a) tampering or attempting to tamper with the entry process or the operation of the "Online Contest" or Sponsor's Website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

By participating, Entrants release and agree to hold harmless the Released Parties from any and all liability for any injuries, death or losses or damages to persons or property AS WELL AS CLAIMS/ACTIONS BASED ON PUBLICITY RIGHTS, DEFAMATION, AND/OR INVASION OF PRIVACY that may arise from participating in this Contest or its related activities or the acceptance, possession, use or misuse of, or any harm resulting from the acceptance, possession, use or misuse of a Prize. "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY."



**WINNER DETERMINATION/NOTIFICATION:** During the Judging Period, each entry will be reviewed by a qualified judge or panel of judges appointed by the Sponsor. Each entry will be judged based on the clear relationship between the submission and the following criteria:

- - 50% Creativity/Originality/Quality of recipe including flavor
- - 25% Overall display of active lifestyle activity
- - 25% Overall display of representation of “what does The Bikini Chef mean to you?”

Amongst the online entries during Round 1 (one) of the Online Contest, the Top 50 entrants (also known as “Semi-Finalists Round 1 (one)”) will be selected based on the judge’s scoring. The Semi-Finalists Round 1 (one) will be invited at their own expense to audition/compete in Semi-Finalists Round 2 (two) of the Online Contest. Semi-Finalists Round 1 (one) Entrants that are invited to participate in Semi-Finalists Round 2 (two) of the Online Contest will be required to wear a swimsuit and participate in sponsor cooking and fitness challenges. In the event there are 50 or fewer total entries for Round 1 (one), the top 25 entries will be invited at their own expense to audition/compete in Semi-Finalists Round 2 (two) of the Online Contest.

Competition for the Semi-Finalists Round 2 (two) of the Online Contest will begin on or around October 15, 2026 and end at 11:59pmPT on December 20, 2026. Based on the judge’s scoring, the Top 25 Semi-Finalists Round 2 (two) of the Online Contest will be invited to participate in the Semi-Finalists Round 3 (three) of the Online Contest. Semi-Finalists Round 3 (three) will compete in social media and also a website profile will be created for each of the Semi-Finalists Round 3 (three) for audience-based voting in addition to the judges voting. Judges votes will count as 75% of the total scoring with audience participation counting as 25% of the overall scoring for Semi-Finalists Round 3 (three) to move to the Finals. In the event there were 25 entries for Semi-Finalists Round 2 (two), the Top 15 finalists will move on to the Semi-Finalists Round 3 (three) competition.

Competition for the Semi-Finalists Round 3 (three) of the Online Contest will begin on or around January 5, 2027 and end at 11:59pmPT on February 28, 2027. The Top 10 Finalists will be based on judges scoring and audience vote with judges scoring representing 75% of the overall scoring and audience-based voting counting as 25% of the overall scoring. Finalists Round 3 (three) will compete in social media and also a website profile will be created for each of the Semi-Finalists Round 3 (three) for audience-based voting in addition to the judges voting. Round 3 finalists will be required to wear swimwear and/or an apron and participate in sponsor cooking and fitness challenges.

NOTE: Throughout Round 1 (one), Round 2 (two), and Round 3 (three) of the Online Contest, Entrants are encouraged to promote their video submissions on their social



media platforms by other supporting videos, posts, comments, and tags. Entrants will be asked to participate in Sponsor cooking and fitness challenges at their own expense.

Based on the Semi-Finalists Round 3 (three) competition, the Top 10 finalists will be invited to compete in the filmed for “television or web streaming” in-person competition at a location to be determined in Fort Lauderdale, Florida or an alternate US-based location determined by the Sponsor. Each of the Top 10 finalists must attend the filmed, in-person competition. Competition and filming to take place at a date in March 2027. Exact dates and location to be announced. Auditions/Competition are subject to broadcast at the Sponsor’s discretion via video streaming platforms including but not limited to the web/internet.

NOTE 2 (two): A Finalist must attend the invite-only in-person auditions in order to accept the First Prize and be eligible for the Grand Prize. If a Finalist cannot attend the invite-only in-person auditions at the location and time selected by the Sponsor, they will be disqualified, and an alternate First Prize Winner/Finalist will be accepted.

The “Online Contest” Finalists will all be invited to Fort Lauderdale, FL or an alternate US-based location to participate in in-person auditions/competition.

The Grand Prize Winner will be selected based upon the final round of in-person auditions/competition to be held at a location to be determined in Fort Lauderdale, Florida or an alternate US-based location on a date to be specified.

**PRIZES:** There will be up to one (1) Grand Prize and four (4) Runner-Up Prizes available.

- - Each Runner-Up Prize Winner (“Winner”), upon the Administrator’s verification of eligibility, will receive a \$500 cash award/check. Runner-Up Prize ARV - \$500 plus Sponsor gift bag, value to be determined.
- - The Grand Prize Winner (also “Winner”), upon the Administrator’s verification of eligibility, will receive a \$1,000 cash award/check (collectively, the “Prize” or “Grand Prize”) plus Sponsor gift bag, value to be determined.

Total Prize Pool - \$14,000. All other expenses associated with Prize acceptance or usage not specifically mentioned herein are the responsibility of the Winners. The Winners will be responsible for all local, state, and federal taxes associated with the receipt of

If a Prize or Prize notification is returned as unclaimed or undeliverable to the potential winner, if a potential Winner cannot be reached or does not comply with notification instructions within three (3) business days from the first notification attempt, or if a potential Winner is not in compliance with these Official Rules, then such person shall be disqualified and, at Sponsor's sole discretion, an alternate Winner may be selected based on the judges' scoring.

By accepting a Prize, where permitted by law, the Winners grant to the Released Parties and those acting pursuant to the authority of Sponsor and the Released Parties (which grant will be confirmed in writing upon Sponsor's request), the right to print, publish, broadcast and use worldwide IN ALL MEDIA without limitation at any time their full name, portrait, picture, voice, likeness and/or biographical information for advertising, trade and promotional purposes without further payment or additional consideration, and without review, approval or notification. The Winners also acknowledge that Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to their Prize.

**DISPUTES:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants, Administrator, and Sponsor in connection with the "Online Contest" shall be governed by and construed in accordance with the laws of the state of Delaware, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws. By participating in the "Online Contest", Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or in connection with the "Online Contest", shall be resolved individually without resort to any form of class action; (ii) any judicial proceeding shall take place in a court within the state of Delaware; (iii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event will attorney fees be awarded or recoverable; (iv) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to seek, punitive, incidental, exemplary, consequential, special damages, lost profits, other damages, and/or any rights to have damages multiplied or otherwise increased; and (v) Entrant's remedies are limited to a claim for money damages (if any) and she waives any right to seek injunctive or equitable relief.

**SEVERABILITY:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, the other provisions will remain in effect and will be construed as if the invalid or unenforceable provision were not contained herein.

**MISCELLANEOUS:** These Official Rules contain the full and complete understanding with respect to the "Online Contest" and supersede all prior and contemporaneous agreements, representations, and understandings, whether oral or written. The headings herein are for



convenience only, do not constitute a part of these Official Rules, and shall not be deemed to limit or affect any of the provisions hereof. No amendment to, or waiver of, any provision of these Official Rules shall be effective unless in writing and signed by both Sponsor and Administrator. The waiver by Sponsor or Administrator of any provision of these Official Rules shall not constitute a waiver of any other provision herein. The rights and obligations hereunder may not be assigned by Entrants, whether by operation of law or otherwise, without the prior written consent of Sponsor, and any attempted assignment in violation of the foregoing shall be null and void. These Official Rules shall be binding upon, and inure to the benefit of, the permitted successors and assigns of Sponsor, Administrator, and Entrant.
